Flogo and BusinessWorks solutions are hosted as part of the TIBCO Cloud environment which was determined to be PCI compliant with version 3.2.1 of the PCI DSS.</p> <p>The Scribe capability is isolated within its own AWS VPC. Scribe provides 'connectors' that are used to integrate commonly used software solutions. Users of Scribe define solutions/apps which provide input and output values that are needed for the connectors to integrate. BusinessWorks and Flogo offer similar solutions, however those capabilities are catered towards a different user persona.</p>


